#### ARTICLE V - EXECUTIVE COMMITTEE

### Section 1: Standing Executive Committee

Delete:

...and elected officials who reside in Manitowoc County and are members of the Republican Party of Manitowoc County.

Section 2: Other Executive committee Members

Delete:

Chairpersons of local affiliates that represent the goals and purposes of the Republican Party of Manitowoc. Such chairpersons must be members of the County Party.

# Article VI – Other Standing Committees

Add:

Section 3: Membership Committee

A committee shall be formed to serve the party members by keeping an accurate membership list, maintaining lines of communication with the county members, welcoming new members and reporting membership information to the 6<sup>th</sup> District. The Chair of the Membership Committee will be the Vice Chairman of the county party. Other members will be chosen by the Standing Executive Committee. Committee will meet as needed and will report to the Standing Executive Committee.

## Section 4: Fundraising/Events Planning Committee

A committee shall be formed to oversee all fundraising activities and events of the county party, being responsible for planning and executing these events. The Chairs of the Fundraising/Events Planning Committee will be both the Chairman and the Treasurer of the county party. Other members will be chosen by the Standing Executive Committee. Committee will meet as needed and report to the Standing Executive Committee.

# Section 5: Campaign Management Committee

A committee shall be formed to assist in locating and assisting local citizens who are qualified and who have expressed an interest in running for local offices (re: county board, city councils, town boards, school boards). The Chair of the Campaign Management Committee will be chosen by, be a member of, and will report to the Standing Executive Committee. Length of term will be by mutual agreement.

Committee members will be chosen by the Campaign Management Chair and the Standing Executive Committee and will meet as needed.

## Section 6: Marketing/Digital Media Committee

A committee shall be formed in order to market the county party, advertise events and maintain the website. The Chair of the Marketing/Digital Media Committee will be chosen by, be a member of, and will report to the Standing Executive Committee. Length of term will be by mutual agreement. Committee members will be chosen by the Marketing/Digital Media Chair and the Standing Executive Committee and will meet as needed.

### CHANGE FOR ARTICLE VII: Meeting and Caucuses

#### Section 2: Annual Caucus

The annual county caucus shall be held prior to the fourth Saturday in January each year at which time delegates and alternates shall be approved to attend the district caucus and the state convention. Delegates and alternate delegates must be current members of the Republican Party of Manitowoc County

In addition, at the annual county caucus we will ask for volunteers – 2 each – to serve on the following committees for the Annual  $6^{th}$  District Caucus: Credentials, Resolutions and Rules. Their appointment will then be shared with the  $6^{th}$  District Chairman who will set up the meetings for these committees prior to the meeting of the Annual  $6^{th}$  District Caucus, usually in early April.
